

## Puppy Holding Agreement

This Agreement, dated as of \_\_\_\_\_, 2023 (the effective date), is between El Riachuelo Dogo Argentino, herein after referred to as “Breeder” and \_\_\_\_\_, herein referred to as (buyer). Buyer agrees to place a \$1000 holding fee on a puppy from Breeder

1. **Non-refundable Holding Fee.** Buyer acknowledges that the holding fee is non-refundable in all circumstances, including but not limited to if the Buyer decides s/he does not want or is no longer able to take the puppy. Upon receipt of the holding fee, breeder agrees to hold the puppy for buyer until it has been weaned and is ready for pick up. The deposit shall be made in US dollars and paid to breeder via bank wire or western union.
2. **Buyer Acknowledgements.** Buyer further acknowledges and agrees that the deposit gives Buyer a “Pick” place but does not guarantee a puppy that fits that a puppy that fits buyer’s preferences will be available when it is Buyer’s turn to pick. Pick places are given on a first come, first served basis and Buyer’s place in line is not negotiable. Breeder cannot and does not guarantee any specific qualities of the puppy when it becomes an adult.
3. **Buyer’s Right to Transfer.** Buyer may elect to have the holding fee transferred to the next litter
4. **Refund at Breeder’s Discretion.** If buyer pays the holding fee, then later decides s/he does not want the puppy for any reason, Breeder is not required to return the holding fee. If, however, Breeder is able to sell the puppy to another buyer within a reasonable amount of time after buyer notified Breeder of his/her decision, Breeder may (in their sole discretion) refund the holding fee to the buyer.
5. **Final Purchase Price.** Breeder and buyer agree that the holding fee shall be applied to the final purchase price of the puppy and the remaining balance will become due before the puppy is shipped and/or ownership is transferred from the breeder to buyer. The total Purchase price for the puppy is \$\_\_\_\_\_. The foregoing purchase price does not include any delivery or shipping charges.
6. **Governing Law.** The Agreement, and all matter arising out of or relating to this agreement, shall be governed by, and construed in accordance with the laws of the State of Florida without regard to conflicts of laws provisions thereof.
